Our decision on your application

Congratulations, I am pleased to tell you that we have approved your application for a New Zealand resident visa.

Your resident visa and travel conditions

We have granted you a resident visa with travel conditions. Your visa allows you to live, work, and study in New Zealand. It will not expire while you remain inside New Zealand.

Your travel conditions allow you to travel outside New Zealand and be granted re-entry into New Zealand as a resident when you return. They are valid until 30 May 2014. They are shown on the "expiry date travel" line, which appears at the top right-hand side of the visa label in your passport.

Expiry of your resident visa

Please note that your resident visa will expire if you leave New Zealand and you do not have valid travel conditions that allow you to return as a resident. If you are travelling outside New Zealand and plan to return after your current travel conditions expire, you will need to apply for a variation of travel conditions, or a permanent resident visa. However, if you do not leave New Zealand, your resident visa allows you to stay indefinitely.

Applying for a permanent resident visa

After you have held your resident visa for two years you will be eligible to apply for a permanent resident visa. This can be done at any Immigration New Zealand (INZ) branch. Permanent resident visas are not subject to travel conditions and



do not expire. If you are granted a permanent resident visa, you will be able to travel outside New Zealand and be allowed re-entry into New Zealand as a resident at any time.

Immigration Act 2009

INZ has changed the terminology it uses. From 29 November 2010, we will use the term visa to mean the authority to travel to New Zealand and stay in New Zealand. We have made this change because of the new Immigration Act 2009. If you applied for a permit before 29 November 2010, INZ will now grant you a visa. This change will not affect your immigration status.
